## **Serial Property Line Adjustment Application Process**

# **1.** Applicant Submits a Serial Property Line Adjustment Application to the Development & Public Works Department

- The application must conform to the *Serial Property Line Adjustment Submittal Requirements Checklist* on page 4 of this application packet.
- Planning Division staff screen the submittal at the front counter to determine whether all required items listed in the *Serial Property Line Adjustment Submittal Requirements Checklist* have been submitted.
- Applications missing required items will not be accepted for submittal.

### 2. City Staff Conduct Detailed Completeness Check

- Planning Division staff conducts a detailed completeness check within 30 days of submittal.
- The assigned Planner notifies the applicant in writing regarding the completeness of the application.
- An application is not be deemed technically complete until all information necessary to evaluate the proposed development, its impacts, and its compliance with the provisions of the Springfield Development Code and other applicable codes and statutes have been provided.
- Incomplete applications, as well as insufficient or unclear data, will delay the application review process and may result in denial.

#### 3. City Staff Review the Application and Issue a Decision

- A Type II decision, made after public notice, but without a public hearing, unless appealed, is issued within 120 days of submittal of a complete application.
- Mailed notice is provided to property owners and occupants within 300 feet of the property being reviewed and to any applicable neighborhood association. In addition, the applicant must post one sign, provided by the City, on the subject property.
- There is a 14-day public comment period, starting on the date notice is mailed.
- Applications are distributed to the Development Review Committee, and their comments are incorporated into a decision that addresses all applicable approval criteria and/or development standards, as well as any written comments from those given notice.
- Applications may be approved, approved with conditions, or denied.
- The City mails the applicant and any party of standing a copy of the decision, which is effective on the day it is mailed.
- The decision issued is the final decision of the City but may be appealed within 15 calendar days to the Planning Commission or Hearings Official.

Copy of the Preliminary Survey Reduced to 81/2" by 11", which will be mailed as part of the required neighboring property notification packet.			
Three (3) Copies of a Preliminary Survey including the following:			
<ul> <li>Prepared, stamped, and signed by an Oregon licensed land surveyor</li> <li>Scale appropriate to the area involved and the amount of detail and data</li> <li>North arrow, date of preparation, and title, i.e. Proposed Property Line Adjustment Survey</li> <li>Boundaries of the lots/parcels involved, including dimensions and area</li> <li>Zoning and plan designation of the lots/parcels</li> <li>Existing property line and proposed property line, clearly differentiated by line type</li> <li>Location and outline to scale of all existing structures, including required setbacks from current property lines and proposed property lines</li> <li>Location, widths, and names of all existing streets, alleys, or other rights-of-way within or adjacent to the lots/parcels and the location and width of driveways</li> <li>Location of all public and private easements and utility lines within or crossing the lots/parcels.
