3/10/2020	Benefits & Leave	Would a COVID 19 exposure be covered by workers' compensation?	In some narrow cases, the work comp carrier may determine that a confirmed positive COVID-19 infection is work related. However, with how quickly this is spreading, it will be difficult to positively determine how the employee was infected and may not be covered. Employees are encouraged to reach out to Human Resources or Risk Management with specific questions.
3/12/2020	Benefits & Leave	Will there be any changes to City sick leave processes?	At this time, employees should follow current sick leave procedures as set forth in the employee's collective bargaining agreement and administrative regulations.
3/8/2020	Benefits & Leave	What if I have no leave time left to take?	Employees who exhaust their leave banks due to a documented flu or COVID-19 illness will not be subject to discipline. Depending on specific circumstances, some employees may be able to utilize sick leave donations. See the Sick Leave Admin Regulations for more information.

3/8/2020	Benefits & Leave	Does the City (or insurance) still provide flu shots?	Yes. The vaccine has been very effective and avoiding the flu will reduce the load on the health system. The Wellness Center in City Hall has a supply of vaccine on hand and can obtain more. Call to make an appointment. 541-242-2816
3/10/2020	Customer Service	What can I do to sanitize my work area?	Use sanitizing wipes or other disinfectant to wipe down counters and door handles. Consider using a "clean" and "dirty" pen holder so that pens can be wiped down between use. A 10:1 water to bleach solution is effective. The solution is only good for 24 hours and must be stored in a labeled container.
3/8/2020	Customer Service	What if customers show signs they are sick?	We normally cannot make the public, even when they are sick, stay away from a public building. We will have brochures and posters at all city locations and on our websites with information regarding the seasonal flu COVID-19. If we do experience a worst-case scenario we would follow Oregon Health Authority (OHA) guidelines concerning access to public buildings.
